- Must be Law Abiding Citizen, able to pass SLED Investigation.
- Must have valid SC Driver's License or I.D. Card in possession. Active Duty Military must have Military I.D. and copy of PCS Orders.
- Must bring quality firearm (unloaded handgun), 100 rounds ammunition, and suitable holster with sturdy belt. (No shoulder holsters, fanny packs, or other exotic holsters).
- Pick up CWP Application and Fingerprint Cards from Sheriff's Department prior to attending class.
- Ear and eye protection required.
- Must call for appointment. Paid pre-registration required. \$125 per Student.

Concealed Weapons Permit Training Registration Information

Dear Student,

CMH Consulting is certified by the State of South Carolina to conduct training of those persons interested in being issued a State Concealed Weapons Permit (CWP).

South Carolina requires that all those applying be South Carolina Residents, 21 years or older, be Law Abiding Citizens, receive 8 hours of training from a certified instructor, apply in writing, submit a photograph, pass a written examination, pay a \$50 fee to SLED, and perform to a minimum standard at the shooting range. CMH Consulting conducts CWP Training each Saturday from 8 am to 4 pm.

The cost of the training is \$125 and must be paid prior to the class date. A maximum of 12 students are able to attend at this time, therefore, the first 12 that pay their tuition will attend the class. The tuition is non-refundable. The class is held rain or shine.

In order to attend, you must complete the enclosed Registration and Waiver Form and mail/deliver it to our office at 126 N. Memorial Ave. in Walterboro S.C. prior to class commencement along with a check or money order for the tuition.

On the day of training, you must arrive on time with the following:

1. A valid South Carolina Driver's License or I.D. Card. Active Duty Military must have a Military I.D. card with a copy of their PCS Orders.
2. A quality, unloaded handgun. Those with semi-automatic weapons are encouraged to bring an extra magazine and those with revolvers, a speed-loader. Students need only qualify on one weapon.
3. A minimum of 50 rounds of target ammunition for their weapon.
4. Ear and eye protection.
5. Rain coat or poncho if rain is expected.
6. A sturdy belt and holster to fit their weapon. No shoulder holster, fanny packs, or other exotic holsters.
7. A CWP Application and set of Fingerprint Cards available from the Sheriff's Department.
8. Ball point pen and paper.

Weapons Training is serious business, and Students are expected to follow all class and range rules as directed by the Instructor. This includes having cell phones turned off or silent during all training. If you are unable to comply, please do not register.
